Introduction

The DHCR Price List provides a comprehensive listing of all fees relating to application, licensing (commercial and professional), Permits, Quality Survey and Government Services.

All applications will be processed through DHCR e-services platform, Masaar at https://www.dhcr.gov.ae/en/#servicesAnchor. Certain activities require approval from external authorities. Refer to Rule No. 1 of 2018 Concerning permitted activities and licensing categories for DHCC.

Commercial License

Commercial License (CL) is issued in accordance with Rule 1 of 2018, Concerning permitted activities and licensing categories for DHCC (as amended).

Relevant fees apply for any additional cluster/segment/activity. A service fee shall apply for any amendment/modification required during the process of new application or for existing facility. All Commercial licenses and Permits shall be valid for a period of one year and renewed annually thereafter.

Clinical Operating Permit

All DHCC Clinical Operators are required to obtain a Clinical Operating Permit (COP) prior to the commencement of business operations. A processing fee of **AED 2,500** shall apply for any changes to the facility location or specialty.





1. Initial Application

- 1.1 A completed online application form with supporting documents is required for being eligible to establish a company in DHCC. The Approved applicants are issued a Provisional Approval Letter (PAL) in order to complete commercial Licensing requirements.
- 1.2 New Application for Commercial License is subject to a 'one-time' fee.

1.3 Note that any service transaction provided by DHCR shall be subject to Government Fees (Knowledge Dirham and Innovation Fee).

2. Commercial License and Clinical Operating Permit Services

This section covers all the fees related to Commercial License and Operating Permit for Healthcare cluster which include Clinical Inpatient and Outpatient, Patient Support, Pharmacies, Laboratories and other additional services.

- 2.1 Operating Permit Fee for hospitals also include Education and Research Permits.
- 2.2 A separate Operating Permit is required for Internal Pharmacies and Reference Laboratories.
- 2.3 For new Business Partners (BP) under Clinical Inpatient, Clinical Outpatient, Pharmacy and Laboratory, a separate one-time fee for pre-op assessment and 6- months' post-op survey shall apply.
- 2.4 For additional re-assessment and re-survey, a separate fee shall apply.
- 2.5 Healthcare Professionals (Doctors, Dentist & Complementary Alternative Medicines) are eligible for Visiting Doctor's License subject to the issuance of LOA from DHCA. The existing Healthcare Professionals (Doctors, Dentist & Complementary Alternative Medicines) having deactivated license status may also apply for the same.
