# Violations Schedule Related to the Hygiene and Maintenance Standards for Properties and Public Areas

## 1. PURPOSE

This Rule is issued under the authority of Dubai Healthcare City Authority (DHCA) as granted by Law No. 16 of 2024, to establish and enforce hygiene, maintenance and engineering standards for Properties and Public Areas within Dubai Healthcare City (DHCC). This Rule aims to ensure public health, safety, environmental protection, and regulatory compliance within Dubai Healthcare City.

This Rule shall be read together with:

- a) DHCA Law No. 16 of 2024; and.
- b) DHCA Rules and Regulations defined in this document.

#### 2. REGULATIONS

Regulations set out the governance framework under which registered companies, Licensees, function in DHCC. All Licensees must comply with the relevant Regulations and applicable Rules, Policies, Standards and Guidelines.

DHCA Regulations are as promulgated and as may be amended from time to time.

- Governing Regulation No. 1 of 2013;
- Healthcare Professionals Regulation No. 2 of 2013;
- Complementary and Alternative Medicine Professionals Regulation No. 3 of 2013;
- Healthcare Operators Regulation No. 4 of 2013;
- Education Regulation No. 5 of 2013;
- Research Regulation No. 6 of 2013;
- Health Data Protection Regulation No. 7 of 2013;
- Company Regulation No. 8 of 2013; and
- Commercial Services Licensing Regulation No. 9 of 2013.





# ARTICLE (1)

# 1.1 Definitions and Interpretations

Capitalized and abbreviated words in this Rule shall have the meaning indicated below:

# 1.2 Effective Date and Authority

This Rule shall take effect on the date of its issuance and supersedes all previous hygiene, maintenance and engineering standards for properties and public areas within DHCC.





## 1.3 Compliance Responsibility

## 1.3.1 Delegation of Responsibilities:

Wherever in this Rule an obligation or duty is placed on a Licensee, a Licensee is authorized to do any act to meet that obligation or duty unless otherwise provided. Such obligations, duty or act may be carried out by the Directors, Owners or Operators.

## 1.3.2 Adherence to DHCA Directives:

All Licensees shall adhere to DHCA directives, and compliance shall be the responsibility of Directors, Owners, and Operators.

#### 1.3.3 Penalties for Non-Compliance:

Failure to comply shall result in penalties as outlined in Appendix 1.

#### 1.4 Time Period Calculation

References in this Rule to time periods shall be construed in accordance with the Gregorian calendar. Whenever a period of time is referenced, it shall include every calendar day, except as provided below in Articles 1.5 and 1.6.

#### 1.5 Weekend Consideration

When the last day of the period falls on a Saturday or Sunday, the period shall end instead on the following Monday.

## 1.6 Public Holiday Adjustment

When the last day of the period falls on a UAE or Dubai public holiday, the period shall end instead on the next working day.

## 1.7 Definition Of "Person"

Unless the context otherwise requires, any reference in this Rule to a "person" includes a reference to:

- a) A natural person.
- b) A corporate body, limited liability company, association or partnership.
- c) The legal or personal representatives, legal successors and lawful assigns of any such person.

## 1.8 Interpretation In Case of Conflicts

In the event of any inconsistency between this Rule and any other applicable law or regulation (whether issued by the Authority or otherwise), the Authority shall determine the correct interpretation, in alignment with prevailing UAE Federal and Emirate of Dubai legislations and each Licensee shall be bound accordingly.

## 1.9 Undefined Terms

Any word(s) used in this Rule but not defined within this document shall have the meaning as contemplated under the respective applicable Rules or Regulations.





## ARTICLE (2)

#### HYGIENE, MAINTENANCE AND ENGINEERING STANDARDS IN DHCC

## 2.1 Compliance Requirements

All entities or persons (including but not limited to owners, contractors and operators) residing, working or operating within the Free Zone must comply with:

- a) Any health and safety policies, standards and guidelines issued by the master developer of DHCC and DHCA from time to time.
- b) DHCA Licensing & Compliance Regulations.
- c) Community hygiene and waste management rules issued by DHCA.

## 2.2 Facility Maintenance Responsibilities

- a) Property owners and/or operators are responsible for the maintenance and upkeep of the Property and shall ensure that all needed facilities management services are provided to Property by licensed and qualified service providers.
- b) Owners and operators shall ensure that all facilities are maintained in accordance with DHCA sanitation standards.
- c) Routine inspections must be conducted by Licensees to ensure ongoing compliance.

#### 2.3 Waste Management Compliance

- a) All entities or persons (including but not limited to owners, contractors and operators) residing, working or operating within the Free Zone must comply with the DHCC community rules and the guidelines issued by DHCA or the master developer to regulate the use of the Public Areas in DHCC.
- b) Strict adherence to UAE Federal Waste Disposal Law for medical and hazardous waste is mandatory.
- Failure to dispose of hazardous waste properly shall be subject to immediate fines and possible license suspension.

## 2.4 Mandatory Reporting

- a) All incidents and accidents which occur at a Licensee's premises, and which result in a person needing medical attention, must be reported to the Authority within 24 hours of the date of the incident/ accident.
- b) Severe violations (e.g., fire hazards, contamination, medical waste breaches) must be reported promptly.





#### ARTICLE (3)

## Inspection and Compliance

## 3.1 Inspection and Enforcement Authority

DHCA is authorized to conduct scheduled and unscheduled inspections within DHCC to ensure compliance with Free Zone Rules, Regulations, guidelines and requirements. DHCA reserves the right to enter any Property within DHCC at any time without prior notice. Licensees must fully cooperate with inspectors, failure of which shall result in administrative penalties.

## 3.2 Compliance Grading System

A compliance grading system shall be introduced to ensure adherence, incorporating:

- a) Warnings for first-time minor violations.
- b) Fines for major or repeated infractions.
- c) License suspension for serious or continued non-compliance.

#### 3.3 Judicial Seizure and Closure

In case of serious violations or repeated incidents that pose a risk to public health and safety, DHCA may:

- a) Issue immediate closure orders.
- b) Suspend licenses until corrective action is completed.
- c) Require mandatory retraining of facility management.
- d) Conduct further legal enforcement actions, if necessary.





## **ARTICLE (4)**

## **Violations**

#### 4.1 Violations and Penalties General Violations

All entities or persons (including but not limited to owners, contractors and operators) residing, working or operating within the Free Zone committing any of the violations stipulated in Appendix 1, shall be subject to the penalties stated therein.

#### **4.2 Unlisted Violations**

Any violation concerning Hygiene, Maintenance and Engineering Standards in DHCC which is not explicitly listed in Appendix 1 shall be reviewed, and penalties may be imposed at the discretion of DHCA.
